| <input type="checkbox"/> <b>OPTION 1.</b> I want to forfeit the full amount of the bail. I agree that a temporary judge may order the bail forfeited and that there be no further proceedings in my case.<br><input type="checkbox"/> <b>OPTION 2.</b> I want to forfeit the bail and attend traffic school. With this form, I am paying the full amount of the bail, plus the \$52 traffic school court administrative fee.<br><input type="checkbox"/> <b>OPTION 3 A.</b> I am requesting an appearance in court for <u>arraignment</u> AND a <u>court trial</u> , to plead <b>NOT GUILTY</b> . I also have the choice of setting both hearings on the same or different dates. <u>Deposit of bail is required</u> under VC 40519(a). I understand that I am not entitled to a public defender or a trial by jury. I further understand that if I do not appear at the trial, the Court will decide the case based on the officer's evidence only.<br><input type="checkbox"/> <b>OPTION 3 B.</b> I request a trial but <u>do not</u> want to appear in person. I understand that both the officer and I will be required to submit declarations stating the facts of the case. The Court will enter a plea of "not guilty" for me and will review the declaration. A written ruling by the Court will be mailed to me. The <i>Request for Trial by Written Declaration</i> (TR-205) forms are available at the Clerk's Office or on our website: <a href="http://www.yuba.courts.ca.gov">www.yuba.courts.ca.gov</a> . | <input type="checkbox"/> <b>OPTION 3 C.</b> I am requesting an appearance in court for <u>arraignment</u> to enter a plea without deposit of bail.<br><input type="checkbox"/> <b>OPTION 3 D.</b> I am requesting an appearance in court for <u>arraignment</u> to request a <u>court trial</u> without the deposit of bail. However, at the arraignment, the court may require a deposit of bail to schedule the court trial and if so ordered, the court will state the specific reason for posting the bail pursuant to Cal Rules of Court, Rule 4.105.<br><input type="checkbox"/> <b>OPTION 4.</b> I am submitting my proof of correction(s) and the \$25 fee for each corrected vehicle code violation, and \$180 for each fishing license proof of correction.<br><input type="checkbox"/> <b>OPTION 5.</b> I would like a 60-day extension of time to choose between Options 1, 2, 3 or 4 above, OR PAY MY FINE IN FULL.<br><input type="checkbox"/> <b>OPTION 6.</b> I request that the Court enter a plea of "guilty" for me, and I want to pay my fine in installments. I waive my right to a trial. I understand I will be referred to Court Collections to set up a payment plan. A Civil Assessment of \$300.00 may be added (PC 1214.1; A DMV hold or suspension may be placed on your driver's license (this information will be available to your insurance company, which may cause your rates to increase); you may be charged with a misdemeanor and a warrant for your arrest may be issued.
